

MINISTER'S LETTER

Dear friends in the faith:

I remember a day, some years ago, when I arrived home from school. My mother invited me into the living room, telling me she had made some changes in the placement of the furniture. Anticipating some degree of surprise I looked around the room very carefully, not wanting to disappoint her. Finally, I had to tell her I saw absolutely nothing changed. She then told me she had done a lot but the family cat disapproved and she put everything back the way it had been so as to keep the peace with the cat. That same pet cat assumed humans could control the weather as on inclement days (especially in the winter) she would demand to go outside. If she did not approve of the current climatic conditions she would turn to the one holding the door open and hiss at them and retreat back into the house and down the basement stairs.

Because we have not had very much snow this winter, the snow that *does* fall tends to create a perfectly white blanket. That blanket of snow covers up some of those out of door tasks which we have left unfinished from the autumn. That same snow offers opportunity to some (mainly younger ones) who see it as something they can fashion into snow figures and snow angels.

Fresh-fallen snow reminds me of new opportunities – opportunities to change the furniture positioning within our personal lives and beyond. It also offers us the opening to try something we may never have done before – perhaps going sledding with our children or our grand-children. It also gives us the chance to see things in a new light.

The story of the Christian faith has always integrated Light and Life into one. We are challenged to step through new doorways into unfamiliar territory knowing we are not alone in our venture. We go with God. When someone throws us a curve and changes our surroundings in an unexpected way, we are to see this in the light of a new experience — a new opportunity.

The year 2019 has thrown its fair share of curves, changes and challenges in our direction: as individuals; as families; and as a Church. So it is we work together through these changes and challenges, but we don't do it in the dark as we are told repeatedly by those who have shared their faith stories with us (not just in the Bible) that the light of God is always there for us (upon us).

As we look back at 2019, notice how the furniture has been moved around (and even stayed the same). Notice too, how maybe we ought to move the furniture into a different configuration. As Christians we are called and challenged to work with one another through change and even implement change.

Remember the story of Christ coming into the world at Christmas; remember, too, the stories of His personal ministry which upset people who feared change as being threatening. And then, too, recall the Promise of God in Christ through the Resurrection of Jesus which tells us all it is really God and God alone who can bring forth the kind of change we all need in this life and beyond.

Study the Annual Report before you: look for evidence of change. Seek out challenge as well. And be assured that no matter what happens to us in terms of change (controlled or otherwise) we always have been, each and every one, a child of God and that will never change.

CHRISTIAN EDUCATION

The Sunday school program currently provides Christian education classes for children ages 2 to 13. Attendance varied from 2 to 10 children. In 2019, Beverly Dafoe, assisted by Deb Brown, read stories to the children and helped the older ones act out some of the parables and learn the stories of Moses, Noah, Jonah, Shadrach, Meshach & Abednego, to name a few. During Advent, we recreated the Christmas Story using a Nativity Scene stable and figurines of Mary, Joseph, Baby Jesus, the Shepherds, the Angels and the animals that someone had generously donated to the Sunday school many years ago. Even the 2 year olds had fun setting the scene for the birth of Jesus.

Each week, the children gather at the front of the sanctuary and sing the Children's Hymn and then listen to Rev. Bob tell them a story. After the story is finished, Rev. Bob gives each child a picture to colour and they gather in the Sunday school room to sing songs and learn more stories about God, Jesus and the people of God.

On December 8th Emmanuel held our Annual White Gift service. The children gladly collected all of the White Gifts that the congregation had brought. Steve and Beverly Dafoe delivered the gifts to the Three Oaks Foundation Women's Shelter along with a cheque for \$480.00, which was gratefully received.

The Sunday school sponsors a little boy from Nicaragua, Vicente Gabriel Nolasco Vilchez and send him monetary support on a quarterly basis of \$117.00 through the Christian Children's Fund of Canada. At Christmas time, we sent an extra \$25.00 as a Christmas gift. On October 1, 2019, Christian Children's Fund of Canada changed its name to Children Believe. Children Believe reflects the brave and beautiful beliefs of every child of all faiths, ethnicities and cultures while still sharing the same mission, vision and values as Christian Children's Fund of Canada has had for nearly 60 years. We will continue our support of Vicente.

East Central Ontario Regional Council (ECORC) Lay- Rep Report

Churches with up to 100 members have 1 lay representative at East Central Ontario Regional Council (about 170 churches from Oshawa to Brockville and north). ECORC supports local communities of faith for the call of ministers, carries on the work of Right Relations with Indigenous People, Mission Work, Covenanting and Clergy Support, Licensed Lay Worship Leaders, etc. Cluster meetings for other inter-church ministry are optional; an on-going gathering of Belleville area churches has been attended by Rev Bob Matheson and Deb Fortin Brown.

An ECORC website and frequent email newsletters have great resources and information; anyone may sign up to receive the emails -- lots to see and learn about the wonderful work of our church.

In May, I attended the Inaugural ECORC Meeting in Lindsay. Uplifting worship and music were highlights. A vial of water from each church area was blessed in worship and will be used for clay for chalices for regional council use. There was a dawn riverside service and very interesting First Nations presentation on water. About 30 youth presented The Creed with actions they created. On Sunday 4 new ministers were ordained, including Pamela Holmes and Sarah Magee (with links to our area) and Brad Ford (Belleville) was re-admitted.

We voted to meet twice a year (in the spring to set direction; in the fall for action planning). ECORC structure, by-laws and procedures were approved in principle in the spring, with suggested revisions to be reviewed and brought back in the fall. For business between meetings, we elected 12 people to the "Assembly of Elders." Elected action teams gather in person or electronically to carry out work and make recommendations to the Assembly of Elders. I was elected as regional Prayer Shawl convenor and gathered 20 prayer shawls from across Eastern Ontario for new and retiring ministers and newly covenanted staff. ECORC staff is much reduced in the new structure Rev Rosemarie Lambie (executive secretary) and her assistant and shared by 3 regions. Working from home are Rev David Timpson (pastoral relations), Sharon Hull (program, mission, youth), Rev Rodney Smith-Merkley (1 day a week – Right Relations with Indigenous communities), and our part-time communications-webpage manager.

Deb Fortin Brown attended the fall meeting as my stand-in on our "Bazaar Day." That meeting passed the structure/by-laws and budget. (Going forward, churches are expected to pay for their lay rep's travel costs as they do for their ministers.)

As things are unfolding, the path has not been entirely smooth, but much good work has been done and there is light ahead.

COMMITTEE OF STEWARDS REPORT

We appreciate the thousands of hours of volunteer work of our church members and the support of people and businesses in the community who have done so much this year for our church life. It costs over \$12,000 a month to keep the church operating at our present level. Most of this money comes from offerings and fundraising. (The offerings cover almost half of the money required most months.) At the last Annual Meeting, the use of \$43,477 from investments was passed to cover shortfalls in 2019. We needed to use \$35,800 of these investments to help cover our costs.

In 2019, our major expenses included removal and trimming of the catalpa trees and a new laser photocopier for the office. We also developed a formal church fire safety plan including a floor plan of the church and the installation of exit lights and signs. Our regular bills include hydro, telephone/internet, natural gas, custodial services and snow removal. This year we were fortunate to have Charles Gibson do our lawn maintenance at no charge. The bathroom floors were replaced by Wilsons Flooring Centre at no cost to us. At this time, we have no plans for major repairs or renovations in 2020.

Stewards manage the Emmanuel United Church Fund including memorial donations and bequests. The money that is donated to our church on behalf of loved ones goes directly into our general account to help cover church expenses. There is a "Bequest Plaque" that hangs at the back of the sanctuary. This plaque lists names of past members and their spouses who have left money to the church in their wills. We would like to encourage members to do this and to become PAR donors also, to help offset bills that occur during the holidays. (This is a monthly donation that comes directly from your bank account.)

The Stewards would like to particularly thank the United Church Women who do the majority of the fund-raising in our church. We would like to extend extra thankyous to Bev Stewart, Cheryl Mound, Deb Fortin-Brown and Beverly Dafoe for all that they do "behind the scenes"! We would also like to take this time to thank Ed Pallo for up-dating our website foxborounitedchurch.ca/ Lastly, we thank our own committee members. They are Jim Stewart (church treasurer), Cheryl Pallo (envelope steward), Marilyn Hoard (secretary), Carolyn Dafoe (chair), Steve Dafoe, Brian Anderson, Donna Kennedy, Bill Hoard, Colleen Murray, Janis Bradshaw-Ethier and Murney Bradshaw for their decision making and maintenance.

As always, we look forward in the years ahead to continued stewardship and service for the life and work of Emmanuel United Church.

The year 2019 saw total Sunday Offerings increase by \$3,018 from 2018. (It should be noted that \$4,113.74 of this year's total offering was received as Gifts in Kind).

Of the 60 issued Envelope/PAR numbers in 2019, 57 contributed; up from 56 who contributed in 2018.

Of those 57 Envelope/Par contributors, the proportion shifted slightly in the categories above \$1000 of contributions.

FINANCIAL REVIEWER'S REPORT

To the Congregation of Emmanuel United Church

We conducted a review of the financial records of the Emmanuel United Church, both receipts and expenditures. This review acts as a double check on the records and ensures that all financial transactions have been properly recorded and the financial position of the Church has been properly reported. Our review of the finances involved comparison of ledger entries, bank statement entries, deposit slips and documentation of assets for the following (see next page for details of assets):

- General Account
- Emmanuel United Church Fund
- Bible Fund
- Mission & Service Fund

We reviewed the methods of counting and recording offerings and donations. Donations were reviewed only back to envelope numbers. The Envelope Steward prepares statements quarterly and receipts within a month of the end of the taxation year.

We reviewed the method of recording and receipting of Memorial donations. Our office administrator mails a receipt along with a letter of acknowledgement as soon as possible after donations are received.

Records of the treasurer were well organized, with clear annotations to explain entries. It was a straightforward process to compare invoices and computer ledger reports with monthly bank statements which include cancelled cheques.

In our opinion, the statement reviewed accurately reflects the financial position of Emmanuel United Church as of December 31, 2019.

We would like to acknowledge the major contribution of time and service of all persons involved in the financial matters pertaining to Emmanuel United Church. Thank you to all for your assistance in preparation of material for us.

BOARD OF TRUSTEES

2019 Annual Report

The Trustees for 2019 were: Jim Stewart - chair, Beverly Dafoe - secretary, Ivan Clare, Stan Dafoe, Ralph Murray, Brian Anderson, Alvin Donaldson and Rev. Bob. We worked closely with the Stewards on the items the Trustees were involved with. We held one meeting during the year to discuss the 2020 budget, and the ongoing projects. All necessary business has, or is being dealt with.

Following is an update on those items;

Insurance – We continue our insurance with John Harvey Insurance, who is the Desjardin agent. Desjardin took over State Farm Insurance. The premium has remained very good in relation to other companies. We have suggested a budget amount of \$3300 for 2020. This is up \$200 from 2019.

Monthly inspections- The monthly inspections continue. Some batteries have needed to be replaced. Fire extinguishers and emergency lighting were certified by First Chance Fire Protection, and the report sent to the Fire Safety Officer. All smoke detectors need replacing as batteries fail.

Drinking water – The drinking water continues to be monitored. Water tests were done in January, April, July, August & November. The test results were all good. Jim Stewart, Beverly and Steve Dafoe are Certified Drinking Water Systems Operators.

Building issues for 2019- We had no major building issues this year. Some minor repairs and upkeep are constantly ongoing.

Catalpa Trees – The Catalpa trees were removed and trimmed by Timbertech Tree Care.

Fire Safety Plan - We worked with the City of Belleville Fire Safety Officer to develop a Fire Safety Plan. You may notice more signage around the Church having to do with "EXITS" and "Fire Extinguishers".

MINISTRY AND PERSONNEL

2019Annual Report

The M & P Committee for 2019 was made up Stan Dafoe, Lori Gatward, and Jim Stewart. The position of Chair was filled by Jim. Jim also reported to the Official Board. We met once during the year to discuss the budget for 2020 and to deal with any other issues.

2020 Budget - Every budget figure was reviewed. We were able to recommend increases for Rev. Bob and Beverly. The 2020 budget of \$92186 is \$ 1820 under the 2019 budget, a decrease of 1.9%

Beverly Dafoe continues with the job of the Office Administrator. She knows that the M & P committee are available for her to bring any concerns forward; Beverly tells us she is happy with the work load. We have told her, we are very happy with her involvement and the hours being booked. We were able to suggest an increase for her, and still keep the budget low. Beverly has settled into the redone office. A new laser printer was purchased to eventually replace the photocopier when its toner runs out.

Rev. Bob - We continue to be available to him for support for any reason. The committee received the new 2020 salary figures for ministry personnel, and were happy to see we exceed the recommended amount. We recommended an increase to his salary, phone, and book allowance, some of which were in excess of the United Church's mandate. The increases were approved at the Official Board.

We would like to thank Rev. Hainer, Rev. Bob Flindall, Carol Watson, Louise Wood and the UCW for being available for Sunday morning service on the occasions that Rev. Bob is unable to attend.

Minister of Music replacement – The music arrangement with Louise and Michael is working quite well. Michael has had to cancel some of his scheduled Sundays, but Louise is available more than she originally planned. Hugh came in for two Sundays they were not available. Carol Watson is still willing to fill in as she has in the past.

.The Committee thanks Rev. Bob, Beverly and all, for their contributions to a very successful year at Emmanuel United Church.

I would like to thank the Committee members for their involvement this year.

Emmanuel United Church Women - 2019 Report

This was a year to try new things and connect with our UCW network and community. Some things continued. Members took turns leading meetings, but not every month as in the past. In months without a meeting, we added community workshops (china mosaic, flower arranging) and in June a wine tour joined by others in the congregation. We thank Bev Stewart (inter-church contact, kitchen upkeep, purchasing), Cheryl Mound (treasurer, convener, communications), Darlene Anderson (secretary) and Sharon Rowsome (Cards & Gifts).

Christian witness: Local Outreach included support for the Community Development Corporation, Adopt-a-Child and 10 local families through Christmas Sharing. Through Kente UCW Roll Calls, we supported local hospices and the National UCW project – Women for Change Zambia. In June we 'fed the loon' for Quin-Mo-Lac. Emmanuel UCW made a 3 year commitment to support the Quinte Hospice Heart & Home Building Drive with June teas and Quilt Raffles. We thank the Official Board for endorsing this project. Quilting was donated by Eastminster's Hand-Quilting group — much appreciated! The first quilt will be raffled in June 2020 and the second in June 2021. We invite all to take tickets to sell on the cheerful Sunflower "Orient Express" quilt.

Christian Study: Delegates attended the Kente UCW Annual and we hosted the Hastings District fall rally with a timely film on how to Reduce use of plastic, packaging and consumerism. We made a donation to the Sunday School in early 2020. A book in memory of member Pat Belyea was given to the church library. A highlight of the year was hosting about 120 people at the interdenominational World Day of Prayer in March. Thanks to Rev Marg Goodwin for leading our learning and planning day leading up to that event and to Rev Bob Matheson for his support at all the events we held in 2020. We work within Kente UCW to collect poptabs, stamps, large printer cartridges, and (new this year) used-up markers. October "Mission Month" provided information on Sundays about Women for Change Zambia, and other environmental and mission work. Special thanks to CC Craig for telling us about Quin-Mo-Lac's Counsellor-in-Training program. A January newsletter and October UCW brochure outlined our work.

Fellowship: Some activities centred on the church community (e.g., the Anniversary Sunday fellowship lunch, Sunday Coffee Time.) We "let go" of the December Tea and exchanged "Secret Pal" gifts the third Sunday of Advent. We gave about 20 prayer shawls, most (but not all) to people from our church family. Outreach to local community included informal "Wool Gatherings", and a VERY popular monthly Card Game attended by about 30 people each month. Thanks to Phyllis Brownson and Pauline Spratt for heading up the card parties, to Bev and Jim Stewart for set-up and support, and to Cheryl Mound for materials and publicity. Key to the UCW are links between churches and, following in the footsteps of others from Emmanuel, Cheryl Mound serves on the Kente UCW executive and on the Executive of Bay of Quinte Conference (East Central Ontario Region) UCW, currently coordinating the 2020 UCW Quin-Mo-Lac Weekend planning team.

<u>Christian Service</u>: Our UCW is a catalyst, supporter and enabler for a list of services. We sent cards for illness/special occasions; visited shut-ins at Christmas with small gifts; provided Christmas gifts of appreciation to the minister, office staff, music leaders and cleaners; placed flowers in the outdoor planter in spring and fall and a poinsettia in the sanctuary at Christmas in memory of past UCW members; stocked and maintained the kitchen; monitored adherence to Health & Safety regulations; and purchased a new fridge. We made new friends through our February Book and Craft Sale and our June Benefit Tea. The UCW provided hospitality when Emmanuel took a turn hosting a 'cluster' meeting of Belleville churches. We do not walk alone.

Emmanuel UCW works with all members of the congregation and we are most grateful for the great help and support we receive for events: the bazaar, ham supper, turkey supper, and catering for local community organizations and families. These activities rely on support from the whole congregation and it is that support which resulted in being able to donate \$22,000 to Emmanuel United Church and \$1500 to the Mission & Service fund of the United Church of Canada.
