



Emmanuel United Church in Foxboro is in Region 11 (East Central Ontario): about 436 churches, from Oshawa to Kingston plus the Lindsay - Peterborough area.

MINISTER'S LETTER

Dear Family of Christ:

"In the beginning, God." This is literally the opening wording of the Book of Genesis in Hebrew. The key name for God in Hebrew (Yahweh) means "I am". We need to remember "God", then, is a verb. Always there: forever at work. The first chapter of Genesis was composed at a time in history when the people of God needed to be reminded of God's Care for them. It is intended to ground their human existence in the knowledge God is always there for them (and this includes us). We need to be reminded the authors of Scripture were never 'scientists' as we understand the word today — nor did they ever perceive themselves in that light.

The intent of the Book of Genesis is to introduce us to the timelessness and the vision God has for the people. We, like those, described in many different ways in the Bible (whether the New or Old Testament), are to be people with a faith founded in God our Creator and Redeemer who share that inherited Vision of God with those in the world of this day and era.

The 'Great I am' is the One who establishes our Foundation in Life itself. When Jesus enters the Created World, He comes to recreate and bolster the Life and Vision in the People of God.

Our United Church Creed which we recite most often at Communion witnesses to the fact God *IS*. It is intended to remind us to have faith in God but also to remember God has faith in *us*.

As a community of faith or congregation, of any denomination — not just us, when we sit down at an Annual Meeting, we are most often focused on *our* work and accomplishments, forgetting or even ignoring what is contained in the pages following the Minister's (or equivalent) remarks are actually the evidence of God working in and through the people of God. In a way, then, for us this Report on the Life of the Church in the year 2023, ought to be seen as not merely the ending of a year, but the seeding of a New Beginning — literally a New Genesis.

Those with 'named' positions in our congregation have struggled to meet the deadline to produce the document before us. This Report is an achievement in and of itself. But there is more.

The *more* is our record of living out our faith in 'weights and measures' which cannot be described numerically on any of the pages contained here. The document speaks as to how God has worked in and through us in 2023. We began the year as a People of Vision.

The Vision lives on.

During our Annual Meeting, remember this is *our* Annual Meeting and the Report for 2023 records our faith at work in the world God provides for us and has endowed us to receive. A printed document such as that before us, should be scrutinized. We don't call into question those who have produced anything within the document's pages, but we look for *our* faith and *our* vision at work.

Our serious, God-given, *always* 'homework assignment' is to look for *our* footprint in the life and work of our congregation. We need to look to see if *our* vision is evidenced within the following pages. I guarantee the footprint of every participant in the life and work of our congregation is evidenced herein.

Our assignment is to work at deepening our faith, breathing in new vision, and deepening our footprints in the life of God working through the Community of God. Always remembering "We are not alone".

Forever beginning. So be it. Amen.

Unfortunately, the children did not return for Sunday School after the shut-down of the church because of COVID. We had a few children attend church with their parents or grandparents throughout the year, but they stayed in the sanctuary and enjoyed the service.

Through Children Believe, the Sunday School was supporting a child from Nicaragua – Liam Jesus Cruz Flores, 2 years old. Liam lives with his mother & father. His father is a casual labourer but his income is unstable and far from adequate to provide for basic needs. Our sponsorship assured that Liam, his family and community would receive proper medical assistance, clean water, education and skills-training programs to overcome poverty and influence change.

Through generous donations from our congregation to the Sunday School account, we were able to continue our support of Liam. The Session & UCW agreed to provide financial aid if there is not enough money to make our quarterly commitments.

Also, at an Official Board meeting, a motion was passed that any money received by the church for Childrens' Music Recitals would go to supporting Liam or any other child we may sponsor in the future.

East Central Ontario Regional Council – 2023 Lay Rep Annual Report to Emmanuel United Church, Foxboro

The **East Central Regional Council** (ECORC), one of 16 regions across Canada, stretches from Oshawa to Brockville and north past Peterborough and Lindsay. This year we have met twice in Hybrid in-person/Zoom meetings.

Representation: As your lay rep, I attended the 2-day ECORC Spring Meeting where retirees were recognized and Working Action Teams/Forums reported, and retiring ministers were recognized. I also attended the ECORC Fall Meeting Friday/Saturday which included the Ordination for Rev Morgan Bell, recognition of Licensed Lay Worship Leaders, reports and recognition of retiring ministers. Other business included passing the budget and granting voting membership in ECORC to retired Designated Lay Ministers. I will attend the Spring Meeting April 27 at Lindsay.

As **ECORC Prayer Shawl Coordinator**, I collected prayer shawls for presentation to retirees and our new ordinand. (These shawls came from various people in the region, including a number from a community member from our own Wool Gathering Group.)

Remit: A major and critical piece of work this year has been encouraging and supporting churches to complete the Remit to grant autonomous organization, within The United Church, to our Indigenous Communities of Faith. I have been part of the ECORC team of callers calling all churches in the Region to provide remit information and check in on their progress toward completing the remit. This is critical to being what we want to be as a church that keeps its promises, honours its commitments and has been working faithfully to attempt to live in respectful relations with our Indigenous fellow members of The United Church of Canada. I attended two excellent webinars on the remit and provided information about how to join those sessions to members of Emmanuel's Official Board who have the responsibility of voting on remits.

Connecting with Others through with the Broader Church: Emmanuel United is entitled to two voting reps and for anyone wanting to see church mission in action, this is a great way to serve, learn and meet some amazing people from other congregations. You can also become involved without being elected to a position. Many events are open to all; and any member of any Community of Faith can either elected to a Ministry team (Faith, Nurture and Justice; Covenant Support; Equity; Ministry Through Property), just join in for long or short-term work on a specific area of interest or simply attend one of the interesting workshops or events both online and in-person held by the various groups at work for the work of the Church.

BOARD OF TRUSTEES 2023 Annual Report

The Trustees for 2023 were: In-term Chairman - Brian Anderson, Secretary - Beverly Dafoe, Jim Stewart (retired Chairman @ November 12, 2023), Alvin Donaldson, Rev. Bob Matheson, Bill McFarlane, Steve Doidge and Stan Dafoe.

Insurance – This is the main item on the agenda for the Board of Trustees. The information was presented to all members via E-mail and an unanimous decision was to continue with our current insurance provider – Desjardins Insurance. The budget for 2024 was set at \$4,160.

Fire Inspection Service – Our new service provider is Hastings Fire Equipment. All fire extinguisher units are to be inspected on a yearly basis. This service was provided in October 2023, accompanied with a certificate.

Monthly Inspections – This is a monthly in-house inspection of emergency lights, smoke detectors, fire extinguishers, exit lights, etc. currently being done with a log book kept of monthly reports.

Drinking Water – The drinking water continues to be monitored, again being done with in-house personnel by a certified drinking water system operator.

MINISTRY AND PERSONNEL

2023 Annual Report

The M & P Committee for 2023 was comprised of Stan Dafoe, Lori Gatward, and Jim Stewart. The position of Chair was filled by Jim until late in the year when it was transferred to Stan. Jim reported our non confidential information to the Official Board and the Stewards. Lori and Stan met in October to prepare the budget for 2024, with Jim adding his comments before we finalized our proposal.

2024 Budget — The budget and actual figures for 2023 were reviewed and a proposed budget for 2024 was completed for presentation to the Official Board at the November meeting. The 2024 budget figure is **\$89,890** compared to 2023's budget of \$87,379. This represents a **\$2500** increase from 2023 mainly due to a 6.8 % cost-of-living increase as suggested by the United Church, as well as relative increases in remuneration for our music director and church administrator.

Beverly Dafoe – Beverly continues to excel as our Office Administrator, and invoices us moderately for her time and efforts. As we all know, she keeps us organized and well informed on the various workings of our church.

Rev. Bob – The M & P Committee met with Reverend Bob recently to discuss any matters of interest. He is quite happy with the support he has from the committees and feels that we have a very robust congregation. He would give us notice if his circumstances were to change or if we need to cover short absences if necessary. Otherwise he is quite content with the current arrangements.

Minister of Music – The music arrangement with Michael is working well and he is usually available at least 2 Sundays a month to share his talents, as well as some special services. He says that he really enjoys our services and congregation (his roots), and we certainly appreciate his contributions.

The Committee thanks Reverend Bob, Beverly and Michael for their contributions to a very successful year at Emmanuel United Church. I would also like to thank the Committee members for their involvement this year, especially Jim Stewart who has looked after us for many years.

COMMITTEE OF STEWARDS REPORT

The year 2023 has brought out the best in us. There were thousands of hours of volunteer work done by our church members and this support has made a great difference to the financial standing of our church. It costs about \$12,000 a month to keep the church operating. The offerings have covered almost half of the money required. Each year our budget shows a short fall. (The use of \$34,204 from investments was budgeted to cover this in 2023.) However, we used only \$20,734 of these investments to help cover our costs, thanks, mostly, to UCW fundraising of \$28,000.

There is a "Bequest Plaque" that hangs at the back of the sanctuary. This plaque lists names of past members and their spouses who have left money to the church in their wills. This year we added Doug and Shirley Stewart. We would like to encourage members to do this, and to become PAR donors also, to help offset bills that occur during pandemics and holidays. (This is a monthly donation that comes directly from your bank account.)

In 2023, the large expenses were paying for the re-furbishing of the front doors of the sanctuary and replacing the flooring in the kitchen, choir room, offices and halls. We have also upgraded the phone service, computer and the office photocopier (which was donated).

The Stewards would like to particularly thank the United Church Women who continued to do fund-raising in our church. We would like to extend extra thankyous to Cheryl Mound, Bev Stewart and Beverly Dafoe. We would also like to thank Jim Stewart for the countless hours he put in on our church finances and subsidies over the many years as a member of this church. He has retired from treasurer but he will remain on our committee as a member. Colleen Murray will be taking over his role as church treasurer. We would also like to take this time to thank Ed Pallo for up-dating our website and to Steve Dafoe for all his custodial duties. Lastly, we thank our own committee members. They are Jim Stewart, Cheryl Pallo (envelope steward), Carolyn Dafoe (chair), Steve Dafoe, Brian Anderson, Donna Kennedy (secretary), Colleen Murray(treasurer), Janis Bradshaw-Ethier, Bill McFarlane and Murney Bradshaw for their decision making and maintenance.

As always, we look forward in the years ahead to continued stewardship and service for the life and work of Emmanuel United Church.

The year 2023 saw total Sunday Offerings increase by \$2,695 from 2022. We welcomed several new members in 2023.

To the Congregation of Emmanuel United Church

We conducted a review of the financial records of the Emmanuel United Church, both receipts and expenditures. This review acts as a double check on the records and ensures that all financial transactions have been properly recorded and the financial position of the Church has been properly reported. Our review of the finances involved comparison of ledger entries, bank statement entries, deposit slips and documentation of assets for the following (see next page for details of assets):

- > General Account
- > Emmanuel United Church Fund
- Mission & Service Fund

We reviewed the methods of counting and recording offerings and donations. Donations were reviewed only back to envelope numbers. The Envelope Steward prepares statements quarterly and receipts within a month of the end of the taxation year.

We reviewed the method of recording and receipting of Memorial donations. Our office administrator mails a receipt along with a letter of acknowledgement as soon as possible after donations are received.

Records of the treasurer were well organized, with clear annotations to explain entries. It was a straightforward process to compare invoices and computer ledger reports with monthly bank statements which include cancelled cheques.

In our opinion, the statement reviewed accurately reflects the financial position of Emmanuel United Church as of December 31, 2023

We would like to acknowledge the major contribution of time and service of all persons involved in the financial matters pertaining to Emmanuel United Church. Thank you to all for your assistance in preparation of material for us.

Prayer Shawl Ministry: 2023 Annual Report

Emmanuel UCW carries out a Prayer Shawl Ministry. "Shawls" are given at times of celebration, life change or need for support, to send a message of God's love. They are meant for anyone in our church family or wider community; e.g., people moving away, coming into our community, entering nursing homes, facing medical challenges, grieving, heading to college, giving birth, getting married, graduating.

They come in many forms: shawls, scarves, lap rugs, stoles, baby blankets... all sizes, shapes and styles for young and old, male or female. For baptisms, we create a small crocheted square with the pattern of a cross. Pocket prayer shawls (a few inches square), are for people to keep nearby as reminders of God's love and our friendship. Pocket Prayer Shawls and crosses are at the back of the sanctuary for anyone to take for themselves or to give to someone they know.

Sometimes a 'shawl' is made for a specific person who is held in our thoughts and prayers as we create their "shawl." At other times, shawls are made without knowing who will receive them and kept until an occasion arises. Shawls are given with a blessing from the church community and blessed during a Sunday Worship service and the following message attached to the shawl: Prayer of Blessing May God's grace be upon this shawl...warming, comforting, enfolding and embracing. May the one who receives this shawl be wrapped in love.

This year we thank Ann Casselman, Cheryl Mound and two community members from our "Wool Gathering Group", Joan and Pat, for creating shawls. Since we started in the Spring of 2018, we have given well over 100 shawls. In one week in 2023, we gave out 5 shawls in that one week! Another example part of Emmanuel's mission statement to "...support our Church, Community, Country and World through worship, music and sharing of gifts."
