

As of January 1, 2019 there are no longer presbyteries or conferences in the United Church. The church now consists of the National Church (Denominational Council) and the local churches (Faith Communities).

To support churches, the national church has staff assigned to assist 16 regions with such things as pastoral relations and preparation for ministry. Emmanuel United Church in Foxboro is in Region 11 (East Central Ontario): about 436 churches, from Oshawa to Kingston plus the Lindsay - Peterborough area.

#### MINISTER'S LETTER

On the first Thursday morning of 2025, I was asked what our congregation is planning in terms of celebrating The United Church of Canada's Centennial. This past year we were reminded our denomination had turned ninety-nine years of age on June 10<sup>th</sup>. Some congregations celebrated communion as a way of remembering our birthday.

In the year 1975, I was studying for my Arts Degree at Trent University. Peterborough, Ontario, was deemed by marketing people as a cross section of the population of Canada. Advertisers would 'test' their commercials on folks in that area. One advertiser using radio air time was The United Church of Canada. Do you remember the slogan for the Mission and Service Fund, "Live Love"? That slogan was heard on a regular basis, especially during my morning commute to classes from my temporary home to the university campus. These commercials, in part, were intended to help us celebrate the fiftieth anniversary of our church.

While our Annual Report for 2024 focuses on the year past and where we have been, I think we could take a look at where we are going or dreaming of going in 2025.

A favourite hymn of Christians of virtually every denomination is *The Church's One Foundation*. Our denomination, in particular, has been noted for working toward unity among all peoples on our planet. Our Church Crest states, in Latin, our dream of all becoming one. That dream and that task are an ongoing adventure and probably will be.

Since 1925 The United Church of Canada has drawn several other denominations into our ranks (adding to the original three of the Methodist Church of Canada, The Congregationalist Church and a large portion of the Presbyterian Church of Canada). There is a United Church in India and more recently (not that recently) the Uniting Church of Australia has been born. We have left a footprint on every continent of the planet.

The dream and the plan to unite three diverse communities of faith in 1925 seemed next to impossible. Union discussions went on for years. One thing which occurred bringing some 'glue' to the process was a committee working on a Hymn book, later titled *The United Church Hymnary*, published in 1925, just in time for the celebration of the birth of our Union.

Every congregation of our denomination has its own unique style which reflects on the uniqueness of each individual with our own talents, gifts, voices and prayers at work. We need to add 'dreams' to that list, too!

When you read the pages in this Report for 2024, please think of the foundation of our congregation as being firm and secure. That is because we recognize Christ as the *real* Foundation. When Jesus walked among human beings in the Middle East over two thousand years ago, he was planting seeds for the future. He shared dreams and aspirations. He shared God's *Inspiration* with mortal human beings.

I want to challenge us all to think about 2025 and what *our* experiences of our Church Home has been, no matter what congregation we may have our roots in (not just those which have brought about this unique congregation through various amalgamations). How can we deepen our footprint where we are and where we travel as we continue on the future path?

As a baptized and baptizing worshipping community may we strive on boldly knowing we are the Body of Christ in the world and **We are not alone!**

Unfortunately, the children did not return for Sunday School after the shut-down of the church because of COVID. We did have 2 children baptized in April but they have not attended church since, probably because we don't have any other children attending church.

Through Children Believe, the Sunday School was supporting a child from Nicaragua — Liam Jesus Cruz Flores, 3 years old. Liam lives with his mother & father. His father is a casual labourer but his income is unstable and far from adequate to provide for basic needs. Our sponsorship assured that Liam, his family and community would receive proper medical assistance, clean water, education and skills-training programs to overcome poverty and influence change.

Through generous donations from our congregation to the Sunday School account, we were able to continue our support of Liam. The Session & UCW agreed to provide financial aid if there is not enough money to make our quarterly commitments.

Also, at an Official Board meeting, a motion was passed that any money received by the church for Childrens' Music Recitals would go to supporting Liam or any other child we may sponsor in the future.

# East Central Ontario Regional Council – 2024 Lay Rep Annual Report to Emmanuel United Church, Foxboro

The **East Central Regional Council** (ECORC), one of 16 regions across Canada, stretches from Oshawa to Brockville and north past Peterborough and Lindsay.

Representing Emmanuel: This year we have met twice in Hybrid in-person/Zoom meetings where I attended in person having other responsibilities at the meetings. At the 2-day ECORC Spring Meeting in Lindsay, a new minister was ordained, retirees were recognized, and Working Action Teams/Forums reported. At the ECORC Fall Meeting at Brighton where business included passing the budget. A highlight for me was the Spring presentation on "The Seven Grandfather Teachings" by Dorothy Taylor of Curve Lake.

As **ECORC Prayer Shawl Coordinator**, I collected prayer shawls from various sources in the region and assisted in their presentation to retirees and new ordinands. (A number of shawls this year came from a community member in our own Wool Gathering Group.)

Broader Church Experience: It has been a real privilege to serve as your Lay Rep for decades, first as the Presbytery/Conference rep and for the last 6 years as Regional Rep. Over the years, working on committees (such as Search Committees, the Mission, Outreach and Advocacy Team, Candidacy Pathways Coordinating Committee, Finance Committee and Coordinator of training courses and workshops for about 40 lay worship leaders from across Eastern Ontario.) I have rejoiced in many friendships formed and the opportunity to witness the inspiring work of our United Church of Canada. It is a wonderful way to deepen faith and commitment to Christ's call to serve others.

How to Connect: You can be involved in the Broader Church without being elected as a Lay Rep from a Community of Faith. First, many events are open to all; and any member of any Community of Faith can attend one-time workshops or events, both online and in-person on a variety of topics. With many churches now not large enough to operate study or mission projects on their own, this is a most welcome service. Second, for short or long-term specific interests, people can also join a sub-group with a specific area of interest. Third, anyone (not just Lay Reps from Congregations) can be nominated and elected to a Ministry team (Faith, Nurture and Justice; Covenant Support; Equity; Ministry Through Property).

**Keeping Aware**: To keep connected and aware of current initiatives, anyone can subscribe to the ECORC newsletter that comes by email every two weeks. Just google ECORC...and you will get there. Even if you don't attend events, you will increase your awareness of the total mission of the church. The coming events section lets you see what's going on in other churches who have posted their events there.

Emmanuel United is entitled to two voting Lay Reps at General Meetings and for anyone wanting to see the church in action, this is a great way to serve, learn and meet some amazing people from other Communities of Faith. Thank you for this opportunity and best wishes to the next Lay Rep to be elected at the February Annual Meeting.

Board of Trustee meeting November 28, 2024,

Insurance – This is the main item on the agenda for the Board of Trustees – The information was presented to all members , and a unanimous decision was to continue with current insurance provider – Desjardins Insurance . With annual suggested increased coverage and increased deductible of \$10,000.0 at a Cost of \$4807. / year .

Budget was approved at \$4900.00 year.

Fire Inspection Service – new service provider is Hastings Fire Equipment, all fire extinguisher units are to be inspected on a yearly bases, this service was provide in October 2024, accompanied with a certificate.

Trustees were in agreement to support the Board of Stewards with parking lot upgrade to improve drainage, and repaving, in 2025.

Monthly Inspections : This is a monthly in house inspection of emergency lights , smoke detection , fire extinguishers , exit lights etc , currently being done with a completion of monthly reports.

Drinking Water – The drinking water continues to be monitored, again done with in house personnel, by certified drinking water system operator.

### **COMMITTEE OF STEWARDS REPORT**

The year 2024 has been a fairly quiet year. There were thousands of hours of volunteer work done by our church members and this support has made a great difference to the financial standing of our church. It costs about \$12,000 a month to keep the church operating. The offerings have covered about a third of the money required. Each year our budget shows a short fall. (The use of \$34,034 from investments was budgeted to cover this in 2024.) However, by using the interest from our investments and the support of fundraising i.e. UCW of \$31,500, we only had to use \$2483.92 of these investments.

There is a "Bequest Plaque" that hangs at the back of the sanctuary. This plaque lists names of past members and their spouses who have left money to the church in their wills. We would like to encourage members to do this, and to become PAR donors also, to help offset bills that occur during closings and holidays. (This is a monthly donation that comes directly from your bank account.)

In 2024, we had no large maintenance issues and monthly expenses were normal. However, in 2025 we have set aside some of our amalgamation funds to repair the drainage and parking lot near Ashley Street.

The Stewards would like to particularly thank the United Church Women who continued to do fund-raising in our church. We would like to extend extra thankyous to Cheryl Mound, Bev Stewart and Beverly Dafoe. We would also like to thank Jim Stewart for continuing to deposit weekly offerings and for assisting Colleen with treasurer duties. We would also like to take this time to thank Ed Pallo for up-dating our website and to Steve Dafoe for all his custodial duties. Lastly, we thank our own committee members. They are Jim Stewart, Cheryl Pallo (envelope steward), Carolyn Dafoe (chair), Steve Dafoe, Brian Anderson (secretary), Colleen Murray(treasurer), Janis Bradshaw-Ethier, Bill McFarlane and Murney Bradshaw. This year we had to say goodbye to Donna Kennedy and we thank her for her time and interest in our church. Welcome to our new members, Dean and Ana Donaldson. Thanks to all for your hard work and continued support.

As always, we look forward in the years ahead to continued stewardship and service for the life and work of Emmanuel United Church.

# **ENVELOPE STEWARD**

The year 2024 saw total Sunday Offerings increase by \$1,477 from 2023. We lost several members throughout the year.

To the Congregation of Emmanuel United Church

We conducted a review of the financial records of the Emmanuel United Church, both receipts and expenditures. This review acts as a double check on the records and ensures that all financial transactions have been properly recorded and the financial position of the Church has been properly reported. Our review of the finances involved comparison of ledger entries, bank statement entries, deposit slips and documentation of assets for the following (see next page for details of assets):

- ➢ General Account
- > Emmanuel United Church Fund
- Mission & Service Fund

We reviewed the methods of counting and recording offerings and donations. Donations were reviewed only back to envelope numbers. The Envelope Steward prepares statements quarterly and receipts within a month of the end of the taxation year.

We reviewed the method of recording and receipting of Memorial donations. Our office administrator mails a receipt along with a letter of acknowledgement as soon as possible after donations are received.

Records of the treasurer were well organized, with clear annotations to explain entries. It was a straightforward process to compare invoices and computer ledger reports with monthly bank statements which include cancelled cheques.

In our opinion, the statement reviewed accurately reflects the financial position of Emmanuel United Church as of December 31, 2024.

We would like to acknowledge the major contribution of time and service of all persons involved in the financial matters pertaining to Emmanuel United Church. Thank you to all for your assistance in preparation of material for us.
