

Emmanuel United Church in Foxboro is in Region 11 (East Central Ontario): about 436 churches, from Oshawa to Kingston plus the Lindsay -Peterborough area.

Dear Emmanuel Family in Christ:

One of those phrases we may have used when we have brought gifts to others to celebrate such events as Christmas or a birthday is 'many happy returns'. Comic strips in newspapers often depict people, not so happily returning purposeless and needless gifts to the seller. Usually these people are not making 'many happy returns'.

On those well-separated Sundays when we have managed to hold worship, not many of us have been 'fully happy and relaxed returnees'. We have come in faith. We have ventured in hope. We have sought out joy and peace. We have known, always, in this House of Worship there is Love. God in Christ alone, is the author of this Love.

Definitely, the building we call Emmanuel United Church has not been its normal hubbub of activity since the coming of COVID19 to our region, but that does not mean we are any the less believers in or carriers, even, of our faith.

We may be finding the pews in the Sanctuary even less comfortable than when listening to sermons or other messages which have challenged us to do *more*. The pews have been uncomfortable because the entire world as we currently have come to know it is less friendly and far more uncomfortable than we have ever known it to be.

I remember the Sunday, when I, as a young, shy and self-conscious fifteen year-old celebrated my Confirmation Vows. I really worried as to whether I was doing everything right, right down to how I held the little piece of bread, ate it and held the cup of grape juice. That day, for me, was likely the day the pews were most uncomfortable. Now, with COVID around, I suspect there is a similar degree of nervousness among those choosing to attend or even not attend worship at Emmanuel in the physical sense.

Just as God's faith in us continues to carry on, so does our faith in God and Christ. We always venture to worship in hope and receive a sense of that Joy which only God in Christ can provide. Even when our numbers have been few, thanks to COVID, we know the *entire* community of faith is with us in spirit.

Many have actually dared to read my Sunday notes. My apologies if they have included some of those 'theological', Greek or Hebrew terms causing you to reach for a dictionary or type the word into an online search. One of the 'blessings' of reading my sermons, I think, is you can take a rest and reflect on what has been written. It is, of course, deemed inappropriate to shout to the preacher during the sermon, "Hold on, Rev. Bob, can you stop for a second while I digest what you just said?" At home, you have that opportunity.

When I have had the rare chance to speak to our neighbouring clergy, I have discovered the numbers of attendees they have had on those Sundays when they have chosen to hold 'in person' worship, are basically the same as ours.

Even as I compose this letter, we really have no idea as to when we will actually have our Annual Meeting to celebrate and reflect on the life and work of the dedicated and faithful connected to our Community of Faith.

Our normal pattern has been to hold the Annual Meeting on the Sunday nearest to Valentine's Day. Our Annual Report is, in fact, our Valentine Card to one another and even to God. While there are those usual facts and figures, underneath is the certainty of faith and dedication of a community taking the Calling of God to serve others, following in the footsteps of Jesus our Lord.

Something which we are looking forward to in 2022 is a certain amount of rebirth of our community as we are joined by members of the neighbouring congregation of Melrose United Church who have chosen to be among us.

Many to all will be known to us and we celebrate their decision to come and be a part of the life, work and faithful mission of Emmanuel United Church.

The church closed in mid-December 2020 due to COVID-19 and didn't officially open again until September 2021. However, those that were responsible to provide reports for the 2020 Annual Report all handed them in to the office in early January 2021 so Beverly Dafoe and Deb Brown could compile the 2020 Annual Report. The reports were delivered to our congregation, ECORC, etc. and a copy was sent to the United Church of Canada when the Statistics Report was filed before the dead line.

Starting in September, music for our Sunday services was provided by Michael Faulkner approximately 2 times a month or by gospel CDs played by Steve Dafoe. Since we didn't have a choir, Michael would provide a beautiful solo each week he played to make the services even more meaningful.

Oct 3<sup>rd</sup> - World Communion was observed with Rev. Bob presenting the elements - no participation by the congregation.

Oct 24<sup>th</sup> – A special service celebrating the opening of "Hospice Quinte". Many thanks to Deb Brown for designing and printing the front and back covers of the bulletin showing photos of this state-of-the-art facility in our community. Thanks also to Stan Dafoe, Shelby MacPherson, Bev Stewart and Beverly Dafoe for their participation in this service.

Nov 7<sup>th</sup> – Remembrance Day Service – highlights by CDs: "Make Me a Channel of Your Peace" by Susan Boyle and John McCraes "In Flander's Fields" recited by Cliff Chatterton.

Nov 28<sup>th</sup> – Advent 1 with restricted Communion. After the service, the Official Board meeting that had been called by Rev. Bob previously took place. The proposed 2022 budget from the Stewards was received and approved and the date for the Annual Meeting – February 13<sup>th</sup>, 2022 was set.

Dec  $5^{th}$  – White Gift Service – Gifts wrapped in white paper and a cheque for \$500.00 were given to the "Three Oaks Foundation" – a shelter and services for abused women and their children.

Dec 12<sup>th</sup> – During the service, the play "The Christmas Box" was presented by members of the congregation.

Dec 19<sup>th</sup> – During the service, "The Christmas Story" was presented by lay readers with special music provided by Carolyn Dafoe, Michael Faulkner and we were blessed to be able to play "Hallelujah" by Michael Faulkner and the late Vange Finkle. Vange's son had recorded the performance on Christmas Eve 2019 and he downloaded it on to a stick so we could play it via a laptop. It was a very moving experience to listen to the beautiful duet.

At this service it was announced that some of the members of Melrose United Church had chosen to amalgamate with Emmanuel! Members of both Boards had attended meetings to discuss amalgamation when/if Melrose United closed the end of January 2022. We can now begin the formal process to complete the amalgamation through meetings with both Boards and Congregations. Welcome, Melrose United Church members in 2022!

The Sunday school program at Emmanuel is currently on hiatus because of the COVID-19 virus. The church was closed in December 2020 and did not re-open until September 5<sup>th,</sup> 2021. When we re-opened, the children did not return because they would have had to wear masks and would not be able to follow all of the protocol of social distancing and health rules that were in place.

On December 5<sup>th</sup> Emmanuel held our Annual White Gift service. This has always been a project for the children to collect all of the White Gifts that the congregation had brought. This year most of the gifts were monetary donations. Steve and Beverly Dafoe delivered the gifts to the Three Oaks Foundation Women's Shelter along with a cheque for \$500.00, which was gratefully received.

The Sunday school sponsors a little boy from Nicaragua, Vicente Gabriel Nolasco Vilchez and send him monetary support on a quarterly basis of \$117.00 through Children Believe, formerly the Christian Children's Fund of Canada. At Christmas time, we sent an extra \$25.00 as a Christmas gift. Children Believe reflects the brave and beautiful beliefs of <u>every</u> child of all faiths, ethnicities and cultures while still sharing the same mission, vision and values as Christian Children's Fund of Canada has had for nearly 60 years.

Through generous donations from our congregation to the Sunday School account, we were able to continue our support of Vicente. The UCW's mandate is to support the Sunday school children and helped out financially with \$200.00 when there wasn't enough money to send to our sponsor child.

## East Central Ontario Regional Council – 2021 Lay Rep Annual Report Submitted by Cheryl Mound

As Emmanuel's voting lay rep, I attended the 2021 ECORC Annual by ZOOM in two parts over weekends in June and September. Meetings opened with Elder Teaching by an indigenous leader. Spring business included the budget, honouring retiring ministers, and the election and commissioning of action teams. I coordinated the prayer shawls for retirees and one new staff member. Fall business included reports from the Forums and reviewing the budget, including creation of a consolidated fund to assist local churches. ECORC voted 98% to become an Affirming Ministry explicitly welcoming to all LGBTQ2S people. We adopted an Anti-Racism policy. The regional UCW has a seat at ECORC general meetings and is linked to the Faith, Nurture and Justice Ministry Team.

I assisted Rev Charles to connect with Rev Karen Valley (national church), Joel Millar (ECORC) and Stephen Fetter (United in Learning) and complete the mandatory training required for all active ministers; Dr. Hainer completed the process to continue as a Voluntary Associate Minister with our church community of faith.

From time to time, I forwarded parts of the twice monthly ECORC newsletter to Board members with related duties. We can witness our church in action on the ECORC website or by subscribing to the newsletter (open to all and well worth reading.) With many churches suspending in-person worship, the website has links to online worship in our region and other inspiring resources/happenings. I attended a four week book club led by Rev Dr Jackie Harper on Bob Joseph's book: <u>21 Things You Need to Know about the Indian Act</u>. A good way to meet other United Church members from our area.

A "Walk Across Canada for Right Relations" was created by the Mission Team at St. Andrew's United, Brighton, led by Rev. Wanda Stride and Helmut Enns (lay rep) and assisted by Rev. Rodney Smith-Merkley (part-time ECORC staff and Minister at Curve Lake.) Each week 38 of us sent in our hours walked and the group "walked from Halifax to Vancouver." A map of Canada with links to First Nations communities in the area we crossed that week supported our learning. Once a week, we met online with someone in indigenous ministry in the area we were 'in'. So grateful for this experience.

Any member can connect in service to our larger United Church on a Ministry team or can join a forum, long or short term. Ministry teams (Faith, Nurture and Justice; Covenant Support; Equity; Ministry Through Property) are elected; nominations will open early spring. Deb Fortin Brown is on the Equity Team and has assisted as coequity monitor at the major meetings this year. Each Ministry Team is linked to Forums open to all. For example, the Formation, Nurture and Justice Team has 11 elected members with links to Forums: Anti-Racism; Children/Young Adults First Third Ministry; 29th Day for Children's Rights in Palestine; Fair Trade; Truth & Nov Reconciliation/Indigenous Justice and Right Relations; Guaranteed Living Income (e.g., Trenton U.C. Warming Centre). The Doing Missions Together forum gave 2021 grants to all 7 projects which applied: Food Boxes - Emmanuel UC Peterborough; Project Hope - Grace United Peterborough; Evaluating the Potential of Rural Connection in ECORC - St. Mark's Cannifton; the Community Advance Project - St. Paul's, Warkworth; Journey of Justice - Claremont/Greenwood; Mini Pantry Food & Basic Needs Outreach - Faith United, Courtice; Extension of Daily (Pandemic) Lunch Program - Bridge Street UC, Belleville. Additional grants in 2022 are Good Neighbour Feast - Grace United, Napanee; and the Catalyst Fund - Greenwood U.C. Any church or group can post an event on the website.

There is always something to see, learn or do in service to our church.

# **BOARD OF TRUSTEES**

## **2021 Annual Report**

The Trustees for 2021 were: Jim Stewart - chair, Beverly Dafoe - secretary, Ivan Clare, Stan Dafoe, Ralph Murray, Brian Anderson, Alvin Donaldson and Rev. Bob. We worked closely with the Stewards on the items the Trustees were involved with. On October 28 all members were contacted by phone or email. A summary of items that may have been of interest was reviewed. Because of the Covid 19 restrictions, it was decided that a physical meeting was not required; Following is an update on those items;

**Insurance** – I have had my usual conversation with John Harvey's office and they have seen nothing unusual happening to their insurance premiums. On reviewing our premium over the last three years, it shows an average increase of 5.3%. Last year we increased the budget by 6% to \$3500. Our actual cost will be \$3408. It was decided that we would increase by 6% this year to \$3613.

Monthly inspections- Because of closure of the Church due to the pandemic, inspections continued but less frequently than usual. Most of the safety lighting, exit lamps, etc. were turned off. Also the hot water tank and UV lamp were shut off to save hydro.

**Drinking water** – The drinking water continues to be monitored. Water tests were done in February, April, & November. The test results were all good. Jim Stewart, Beverly and Steve Dafoe are Certified Drinking Water Systems Operators.

**Building issues for 2021-** We had no major building issues this year. Steve rebuilt the outside step into the Sunday school room in time for the yard sale and purchased a new salt & sand bin for the north sidewalk. Other minor repairs and upkeep are constantly ongoing.

# MINISTRY AND PERSONNEL

# 2021 Annual Report

The M & P Committee for 2021 was made up Stan Dafoe, Lori Gatward, and Jim Stewart. The position of Chair was filled by Jim. Jim also reported to the Official Board. We met once during the year on October 29 to discuss the budget for 2022 and to deal with any other issues.

**2021 Budget** – The budget and actual figures for 2021 were reviewed and a proposed budget for 2022 was completed for presenting to the Official Board at the November meeting. The 2022 budget figure is **\$86704** compared to 2021's budget of \$82711. This represents a **\$3993 increase** from last year and covers a cost of living increase of 1.3 % suggested by the United Church, the difference in cost for an organist and a recommended small increase for Beverly.

**Beverly Dafoe** - continues to do a good job as the Office Administrator, and has increased her rate to the amount given her last year. Of course her work load has changed because of the closure and partial reopening of the Church caused by Covid. Her invoices have been very minimal and way under budget. Beverly was added as an ADP contact person last year.

**Rev. Bob** – Update on Rev. Bob: He is not looking at retirement at this time and quite happy with the support he has from the congregation and committees. He has said he would give us warning if circumstances were to change. It was pointed out that we should be mind full of his health and that of his family members and be prepared to cover for him if the need arises.

**Minister of Music** – The music arrangement with Louise and Michael was working quite well. Louise has advised us that she is removing herself from our arrangements due to family obligations that have increased recently. Michael has been playing two Sundays a month and agreed to Christmas Eve service. The music situation will be reviewed early in the New Year. Michael has told Beverly he is available for more Sundays. Attendance and revenues will be taken into the decision making. We will provide enough in the budget to cover several scenarios.

The Committee thanks Rev. Bob, Beverly and all, for their contributions to a very unusual year at Emmanuel United Church.

I would like to thank the Committee members for their involvement this year.

# Emmanuel United Church Women – 2021 Report

This was a year to take new turns in the road. When we got respite from the pandemic after Easter, new life appeared as we continued to seek out new ways to connect with our church, broader community and interchurch UCW network. We thank Bev Stewart (inter-church contact, kitchen upkeep, purchasing), Cheryl Mound (treasurer, convener, communications), Darlene Anderson (secretary) and Sharon Rowsome (Cards & Gifts, "Supplies & Services" collections). We also thank Jean Donaldson for her faithful support, Marie Beaudrie for always being there and Doreen Nault for her friendship and project leadership.

**Christian witness:** Through Kente UCW we collected pop tabs, stamps, large printer cartridges, and used-up markers. We donated to Adopt-a-Child, assisted the church to provide for 10 families through Christmas Sharing and gave to Camp Quin-Mo-Lac through Area UCW roll calls. Our "Log Cabin" quilt raffle for Hospice Quinte began June 2020 with the draw June 2022. Some attended the area UCW Fall Rally (in person & live-streamed) and we hosted a meeting of the area executive in May. Cheryl Mound was elected to the executives of Kente Area and the Regional UCW; as Vice-President of the regional UCW, she sits on the National UCW executive.

<u>Christian Study & Fellowship</u>: We found ways to gather safely for 3 or 4 inperson lawn or hall friendship meetings with women of the congregation. UCW members met for a few Zoom meetings and one in-person business meeting in late fall. Most connections were by email, phone or weekly messages to the congregation. Wool Gatherings, Card Parties and other gatherings remain on hold. The UCW's 60<sup>th</sup> Anniversary throughout 2022 will provide inter-church contact/celebration.

<u>Christian Service:</u> Reduced gatherings made keeping in touch with those who might need support more difficult. Still, we gave 17 prayer shawls to Emmanuel and community members and sent cards for illness/special occasions. Shuts-ins received small gifts at Christmas. We gave Christmas gifts to the minister, office staff, cleaner and organist. We placed spring and fall flowers in the outdoor planter and a poinsettia in the sanctuary at Christmas in memory of past UCW members.

Fundraising: People seemed to appreciate a chance to get out and do something! An August Outdoor Yard Sale went well and gave community people a way to profit from pandemic time spent 'de-cluttering.' Meals served curbside or by group delivery, sandwich trays and small funeral receptions when possible) needed fewer workers in shifts spread over two or three rooms. Meat pie sales went well as did 'catalogue' sales for "Christmas in July" and the bazaar "pick-up & shop day." Thursdays at the Belleville Market made new friends. Over 30 people were involved in the catalogue and bazaar: making crafts, sewing. knitting/crocheting, preparing sweets, meat pies or preserves, donating basket items and making up baskets, staffing tables, gathering materials, cutting birch and arranging planters --- we thank ALL for being there whenever help was needed.

We met our 2021 UCW commitment of \$1500 to M&S, gave \$16,500 to the church and \$200 to the Sunday School. We are grateful for so many in the congregation who support their community church. The 2022 UCW theme: "Continuing in Hope!"

#### COMMITTEE OF STEWARDS REPORT

#### Respectfully submitted by: Carolyn Dafoe and the Committee of Stewards

This year was another year to remember. The coronavirus (covid 19) closed our church in January, February, April and the summer months. We were open from September 5 to December 24. It looks like we will be closed for at least one month in 2022. It costs over \$12,000 a month to keep the church operating. Most of this money usually comes from offerings and fundraising. (The offerings have covered almost half of the money required in past years.) This year the government stepped in with a wage subsidy of \$23,651.67 to help us out during the pandemic. (Our members also continued to financially support us as well.) Each year our budget shows a short fall. (The use of \$41,271 from investments was budgeted to cover this in 2021.) However, we used only \$6911.92 of these investments to help cover our costs, thanks, in part, to memorial donations of \$15,045, UCW fundraising of \$16,500 and government assistance.

There is a "Bequest Plaque" that hangs at the back of the sanctuary. This plaque lists names of past members and their spouses who have left money to the church in their wills. We would like to encourage members to do this, and to become PAR donors also, to help offset bills that occur during the pandemic and holidays. (This is a monthly donation that comes directly from your bank account.)

# FINANCIAL REVIEWER'S REPORT

To the Congregation of Emmanuel United Church

We conducted a review of the financial records of the Emmanuel United Church, both receipts and expenditures. This review acts as a double check on the records and ensures that all financial transactions have been properly recorded and the financial position of the Church has been properly reported. Our review of the finances involved comparison of ledger entries, bank statement entries, deposit slips and documentation of assets for the following (see next page for details of assets):

- General Account
- Emmanuel United Church Fund
- Bible Fund
- Mission & Service Fund

We reviewed the methods of counting and recording offerings and donations. Donations were reviewed only back to envelope numbers. The Envelope Steward prepares statements quarterly and receipts within a month of the end of the taxation year.

We reviewed the method of recording and receipting of Memorial donations. Our office administrator mails a receipt along with a letter of acknowledgement as soon as possible after donations are received.

Records of the treasurer were well organized, with clear annotations to explain entries. It was a straightforward process to compare invoices and computer ledger reports with monthly bank statements which include cancelled cheques.

In our opinion, the statement reviewed accurately reflects the financial position of Emmanuel United Church as of December 31, 2021.

We would like to acknowledge the major contribution of time and service of all persons involved in the financial matters pertaining to Emmanuel United Church. Thank you to all for your assistance in preparation of material for us.

#### Prayer Shawl Ministry: Annual Report

#### Submitted by Cheryl Mound for UCW

Emmanuel UCW carries out a Prayer Shawl Ministry. "Shawls" are given at times of celebration, life change or need for support, to send a message of God's love. They are meant for anyone in our church family or wider community; e.g., people moving away, coming into our community, entering nursing homes, facing medical challenges, grieving, heading to college, giving birth, getting married, starting a new job, graduating.

They come in many forms: shawls, scarves, lap rugs, stoles, baby blankets... all sizes, shapes and styles for young and old, male or female. Pocket prayer shawls (a few inches square), are for people to keep nearby as reminders of God's love and our friendship. For baptisms, we create a small crocheted square with the pattern of a cross.

Shawls are given away, with a blessing from the church community; they are never sold. Prior to the pandemic, shawls were blessed during a Sunday Worship service; in 2021-22, prayers were made as shawls were being chosen for giving.

Sometimes a 'shawl' is made for a specific person held in our thoughts and prayers as we create their "shawl." At other times, shawls are made without knowing who will receive them and kept until an occasion arises. A supply of shawls and blessing cards is on hand in the 'choir room' so anyone can take a shawl for someone at any time. Just let Bev Dafoe know so we don't duplicate. We can also create one to suit a particular person or special occasion; just let Cheryl Mound know if you know of something coming up.

We thank Ann Casselman, Donna Kennedy, Cheryl Mound and Marion Coulter for creating shawls. Since we started in the Spring of 2018, we have given over 80 'shawls.' In 2021, we gave 17 shawls, many going to people in community. Another example of Emmanuel's mission of Christian service.
